



## United Energy Around the Bay 2024

Updated 23.05.2024

These Terms and Conditions of Entry (“Entry Terms”) are designed to enable United Energy Around the Bay 2024 (the “Ride”) on Sunday 6 October 2024 to run effectively. By registering to participate in the Ride, you (the “Rider”) accept and agree to be bound by these Entry Terms.

### Entry Requirements

1. The Rider may elect to take part in one of the Ride Options. The ride lengths may not match the exact distance promoted.
2. All riders, including those aged 14 and under riding on a free Kids ticket, must be registered to participate in the Ride.
3. An Entry is not considered to be complete until all required rider information is supplied and payment in full has been received.
4. The Rider warrants that they has prior experience or will obtain experience riding in groups.
5. The riders warrants that they can maintain a minimum average speed for the following ride distances
  - a. 6km per hour for the Family Ride option
  - b. 10km per hour for the 50km ride option
  - c. 12km per hour for the 100km ride option
  - d. 16km per hour for the 135km ride option
  - e. 20km per hour for the 200km ride option
  - f. 21km per hour for The Classic ride option
  - g. 26km per hour for the 300km option
6. Bicycle Network may, in its absolute discretion, and without giving reasons for its decision, accept or refuse an application for Entry.

### Age Requirements

7. The following minimum age requirements must be met by all Riders on the day of the Ride:
  - a. 12 years or older on the >100km (but <200km) ride option/s
  - b. 15 years or older on the >200km ride option/s
8. All Riders under the age of 18 (“Under Age Child) must be accompanied on the Ride by a registered Rider over 18 years old (“Guardian”) as nominated at the time of registration.
9. There is no minimum age requirement on the Family Ride or 50km ride, but all Riders must be competent riding in an on-road environment and able to comply with all other clauses with these Entry Terms.

### Cancellations & Refunds

10. Any cancellation, or request to refund, must be received by the event organizers at least 60 days prior to the Event date, OR by the date/s specified below, whichever comes second.
  - a. For Around the Bay, this date is Friday 9 August 2024, 11:59pm.
11. If the Rider wishes to cancel their registration for the Ride, the Rider can do so via the registration platform (Race Roster) or by contacting Bicycle

12. Cancellations received prior to Friday 9 August 2024, 11:59pm, will be refunded in full, less a \$10.00 administration fee.
  13. No refunds will be offered for cancellations received after Friday 9 August 2024, 11:59pm.
  14. If a cancellation request is received within 60 days of the Event, medical exemptions supported by an Australian's Doctors Certificate will be considered by the event organisers for a 50% refund only.
    - a. If the Rider wishes to transfer instead, please see "Transfers to the Following Year".
    - b. Medical refunds or transfers are subject to a \$10.00 administration fee.
  15. Except as otherwise stated in these Entry Terms and as required by law, Bicycle Network is under no obligation to refund monies or entry fees due to non-use, cancellation, failure to participate or dissatisfaction by the Rider.
  16. Merchandise items or selected add-ons are not refundable.
  17. A \$10.00 admin fee will apply per registered rider making any change to their entry.

#### **Changes to Ride Extras, Add-Ons, and Merchandise**

1. Merchandise items are non-refundable.
2. Selected add-ons are not refundable.
  - a. Carbon Offset is not refundable.
  - b. Bicycle Network Membership is not refundable.
  - c. Donations are not refundable.
3. The Rider may add, change and remove other selected add-ons or ride extras, under the complete discretion of Bicycle Network, up until 30 days prior to the Event.
  - a. Any change is subject to a \$10.00 administration fee.
  - b. Any change of ride extra or add-on is subject to availability.
4. Bicycle Network reserves the right to limit the sale of any ride extra or add-on.
5. A \$10.00 admin fee will apply per registered rider making any change to their entry.

#### **Upgrades and Downgrade**

6. Any request to upgrade or downgrade distance must be received by the event organizers at least 30 days prior to the Event date, OR by the date/s specified below, whichever comes second.
  - a. For Around the Bay, this date is Friday 6 September 2024, 11:59pm.
7. If the Rider wishes to upgrade or downgrade their registration for the Ride, the Rider can do so via the registration platform (Race Roster) or by contacting Bicycle Network directly on 1800 639 634, or by writing an email to [riderservices@bicyclenetwork.com.au](mailto:riderservices@bicyclenetwork.com.au).
8. The Rider will pay an administration fee of \$10.00 per upgrade, downgrade, or other change.



9. If the Rider changes to a ride option (sub-event) with a higher entry fee, the Rider will be required to pay the difference between the entry fee paid and the higher entry fee, at the current price (plus a \$10.00 administration fee).
10. If the Rider changes to a ride option (sub-event) with a lower entry fee, the difference between the entry fee paid and the lower entry fee will be refunded (less a \$10.00 fee).
  - a. No refund however will be available for the difference between entry fees paid after Friday 9 August 2024, 11:59pm, per the Cancellation and Refunds Terms.
11. A \$10.00 admin fee will apply per registered rider making any change to their entry.

### **Transfer of Name**

1. The Rider may request to transfer their registration for the Ride to another Rider by using the Race Roster registration portal, or by contacting Bicycle Network directly on 1800 639 634, or by writing an email to [riderservices@bicyclenetwork.com.au](mailto:riderservices@bicyclenetwork.com.au).
2. Any transfer of Rider name will be subject to a \$10.00 administration fee.
3. Any transfer of Rider name request must be completed by 14 days out.
4. Transfer of name is at the absolute discretion of Bicycle Network.
5. A \$10.00 admin fee will apply per registered rider making any change to their entry.

### **Transfer to the Following Year**

1. The Rider may request to transfer their registration for the Ride to the following year by using the Race Roster registration portal, or by contacting Bicycle Network directly on 1800 639 634, or by writing an email to [riderservices@bicyclenetwork.com.au](mailto:riderservices@bicyclenetwork.com.au).
2. Any transfer to the following year will be subject to a \$10.00 administration fee.
3. Any transfer is subject to the absolute discretion of Bicycle Network.
4. If granted, any transfer is valid only for a maximum of 12 months.
5. Transfers may be offered to the rider in the form of a credit.
  - a. This credit will be provided to the applicable dollar value as paid (less a \$10.00 fee).
6. Any transfer request must be completed by 30 days prior to the Event, or by the date/s specified below, whichever comes second.
  - a. For Around the Bay, this date is Friday 6 September 2024, 11:59pm.
7. If a transfer request is received within 30 days of the Event, medical exemptions supported by an Australian's Doctors Certificate will be considered for a 50% transfer to the following year in the form of a credit.
  - a. This subsequent transfer would be subject to a 50% refund if requested in the following year, provided an Australian Doctor's Certificate is presented, otherwise the ticket is forfeited.
  - b. In each case, medical refunds or transfers are subject to a \$10.00 administration fee.
8. A \$10.00 admin fee will apply per registered rider making any change to their entry.



### **Transfer to a Different Event**

1. The Rider may request to transfer their registration for the Ride to the following year only by contacting Bicycle Network directly on 1800 639 634, or by writing an email to [riderservices@bicyclenetwork.com.au](mailto:riderservices@bicyclenetwork.com.au).
2. Any transfer to a different event will be subject to a \$10.00 administration fee.
3. Any transfer is subject to the absolute discretion of Bicycle Network.
4. If granted, any transfer is valid only for a maximum of 12 months.
5. Transfers may be offered to the rider in the form of a credit.
  - a. This credit will be provided to the applicable dollar value as paid (less a \$10.00 fee).
6. Any transfer request must be completed by 30 days prior to the Event, or by the date/s specified below, whichever comes second.
  - a. For Around the Bay, this date is Friday 6 September 2024, 11:59pm.
7. A \$10.00 admin fee will apply per registered rider making any change to their entry.

### **Ride Communications**

18. Ride Communications will be made via email. The Rider is therefore required to provide a valid email address upon Entry.
19. The Rider consents to receiving and reading all information that is made available on the Bicycle Network website, in email newsletters, the Ride Guide and all other literature concerning the Ride.

### **Mode of Transport**

20. E-Bikes and standard, human-powered bicycles are permitted on all ride options.
21. Unicycles, scooters, motorised bicycles (other than e-bikes), child seats, tagalongs and trailers are not permitted on the 100km, 135km, 200km, 221km and 300km Ride Options.
22. Animals are not permitted on the event.
23. Recumbents and non-standard human-powered bicycles are permitted on Ride Options, however it recommended these bicycles start at the rear of the last wave.

### **Merchandise**

24. All riders >100km (excluding any free tickets) who register and pay in full during the official pre-sale period will be eligible to receive an official jersey.
25. 300km riders must finish the event to receive their jersey.
26. Children who register for a free ticket do not receive a jersey.
27. There are no refunds on merchandise items.



### **Acknowledgment and Waiver**

28. The Rider acknowledges and agrees that participation in the Ride is inherently dangerous and that they participate in the Ride at their own risk.
29. In consideration of Bicycle Network permitting the Rider to enter and participate in the Ride, the Rider hereby releases and indemnifies Bicycle Network, the sponsors of the Ride and any of their respective representatives from and against all and any claims, suits, demands, liabilities, loss and damage (including indirect and consequential loss), costs, expenses and, interest, whether pursuant to common law or statute, that the Rider may suffer or incur arising from or connected with the Rider's participation in the Ride including as a result of the negligence, breach of duty, breach of care or other fault or responsibility of Bicycle Network, the sponsors of the Ride and any of their respective representatives.
30. If the Rider is a parent/guardian of a person under 18 years ("Under Age Child") who is participating in the Ride, that Rider consents to the Under Age Child participating in the Ride and agrees to take full and sole responsibility for the Under Age Child's safety and participation in the Ride. The Rider further agrees and undertakes to Bicycle Network for and on behalf of the Under Age Child that the release and indemnity contained in clause 32 applies with full force and effect to the Under Age Child and that the Rider and any spouse or defacto spouse or partner will take no steps of any sort on behalf of the Under Age Child that would result in the release and indemnity in clause 32 being rendered inoperative, of no effect or being declared or ordered by a court of law as not applying to the Under Age Child.

### **Compliance with Laws**

31. During the Ride, the Rider must comply with all traffic and road laws, all directions issued by Police and all instructions given by Bicycle Network or any employees or officials representing Bicycle Network at the Ride. Failure to do so may result in the Rider being removed from the Ride and they will not receive a registration refund.
32. Riding over the Westgate Bridge: There is to be no stopping on the bridge at any time. It is illegal to ride on the bridge prior to it being officially opened by event marshals. Fines apply.
33. The lane closure on the Geelong freeway is to be used as a buffer lane and overtaking lane. Riders are encouraged to use the emergency lane where possible.
34. While riding a bicycle, the Rider must wear an Australian standard cycling helmet at all times during the Ride.
35. The Rider must not ride at night, or in hazardous weather conditions causing reduced visibility, unless the bicycle, or the Rider, displays:



- (a) A flashing or steady white light that is clearly visible for at least 200 metres from the front of the bicycle; and
- (b) A flashing or steady red light that is clearly visible for at least 200 metres from the rear of the bicycle; and
- (c) A red reflector that is clearly visible for at least 50 metres from the rear of the bicycle when light is projected onto it by a vehicle's headlight on low-beam.

### **Preparation, Training, Health and Safety**

- 36. The Rider is responsible for ensuring that they have adequately and appropriately prepared both physically and mentally for the Ride. If the Rider has any health issues or doubts prior to the Ride, they should seek appropriate medical advice.
- 37. It is solely the Rider's responsibility to carry on themselves at all times, suitable food and/or medication which may be necessary to treat any particular medical condition that the Rider suffers from.
- 38. If, during the Ride, the Rider becomes ill or is injured, Bicycle Network will endeavour to arrange medical transport, usually in an ambulance. Any medical transport will be at the Rider's expense. (Bicycle Network recommends that Riders hold current ambulance service membership and /or health insurance to cover such costs; Bicycle Network membership includes bike crash insurance for bicycle accidents. Please visit [bicyclenetwork.com.au](http://bicyclenetwork.com.au) for more details).
- 39. The Rider is responsible for ensuring that their bicycle is properly serviced, roadworthy and suitable for the event.

### **Common Sense**

- 40. The Rider must ride in a safe and responsible manner during the Ride and use common sense at all times.
- 41. The Rider must exercise caution on all public roads and other thoroughfares and ride defensively and courteously.
- 42. The Rider must not smoke, vape, or use e-cigarettes in designated event sites.

### **Meal and dietary requirements**

- 43. Bicycle Network offers six meal types for the Ride – Standard, Vegetarian, Vegan, Gluten Free Standard, Gluten Free Vegetarian and Gluten Free Vegan.
- 44. If these options do not meet a Rider's dietary requirements, the Rider must consider alternate ways in which to personally cater for their own meals.



45. Every effort is made by Bicycle Network and the appointed caterers to ensure that recipes and ingredients are controlled. Bicycle Network and their caterers cannot however, guarantee that any meal or food item is exactly as described - contamination by allergens can occur that is beyond Bicycle Network and or the caterer's reasonable control.
46. Meals provided for the Ride not intended to provide full nutrition for each Ride Option. We expect that riders will adequately cater to their nutritional requirements while undertaking their chosen ride distance.

#### **Ride and Ride Option Variation**

47. Bicycle Network reserves the right, in its absolute discretion, to cancel, postpone, reschedule or change the time and/or place of the Ride and any of the Ride Options for any reason and at any time prior to the commencement of the Ride, without prior notice.
48. Bicycle Network is not or liable to the Ride Participant for any loss, damage, cost or expense, whether direct, indirect, incurred by the Ride Participant that may result from any action taken by Bicycle Network.
49. Bicycle Network reserves the right, in its absolute discretion, to refuse to allow the Ride Participant to participate in the Ride, or to remove the Ride Participant from the Ride for breach of these terms and conditions, or if it determines it appropriate to do so.

#### **Private support vehicles**

50. Private support vehicles are not permitted on the Ride. Riders found to be making use of private support vehicles may be expelled from the event.

#### **Photography**

51. The Rider acknowledges and agrees that they may be photographed or filmed during the Ride and consents to Bicycle Network using the Rider's picture and likeness contained in any photographs or film for publicising the Ride and for promoting any future ride or event to be staged by Bicycle Network.
52. The parent/guardian acknowledges and agrees that their Under Age Child may be photographed or filmed during the Ride and consents to Bicycle Network using the Rider's picture and likeness contained in any photographs or film for publicising the Ride and for promoting any future ride or event to be staged by Bicycle Network.

#### **Privacy**

53. Bicycle Network collects, uses, discloses and otherwise handles the Rider's personal information in accordance with the terms of its Privacy Policy Statement (see <https://www.bicyclenetwork.com.au/about-us/governance/#documents> – *Privacy Policy*). All information remains the property of Bicycle Network.
54. The Rider consents to their details being shared with our partners and event sponsors.



#### **Other**

55. The Ride will be held outdoors and may proceed notwithstanding poor weather conditions on the day of the Ride. Bicycle Network is not liable to the Rider for any loss, damage, cost or expense of any kind including, but not limited to, refund of entry fees, in the event of poor weather before or during the Ride including valet service.
56. Riders must attach the timing device provided by Bicycle Network in the correct manner to their bicycle prior to commencing the Ride and keep it attached for the duration of the Ride if they are to receive an official event time.
57. Bicycle Network reserves the right, in its absolute discretion, to refuse to allow the Rider to participate in the Ride or to remove the Rider from the Ride for breach of these terms and conditions or if it otherwise determines it appropriate to do so.
58. Bicycle Network is not liable to the Rider for any loss, damage, cost or expense of any kind, including but not limited to, the refund of the entry fee, if the Rider is denied access to or removed from the Ride for any reason.
59. "Bicycle Network" means the Bicycle Network Incorporated ABN 41 026 835 903 and includes where appropriate Bicycle Network's employees, volunteers, agents, contractors, and officers.
60. By choosing to fundraise for Maddie Riewoldt's Vision, you have consented to being contacted by their team. #### **Exclusive promotional offers**

62. Bicycle Network has the right to offer special promotional offers throughout the marketing campaigns as incentives to different segments of riders. These offers include value additions and discounts. These offers are not available to all riders and can be added or removed at the discretion of Bicycle Network.
